Further, the candidates are required to bring the Identity Card and the Admission Cards on the day of the Selection Test, duly signed by the Presiding Officer and attested by the concerned Prl. District and Sessions Judge compulsorily, failing which the candidates will not be allowed to take up the Selection Test.
